### **Strategy Overview**


Short-Term High Quality Bond Strategy is a separate managed institutional portfolio focused on liquidity, capital preservation, and total return. We seek to accomplish this through sector allocation, security selection, and duration management. The strategy seeks to maintain a portfolio duration that is approximately three years. Security investment is focused on United States government Treasuries, agencies, and bonds/commercial paper. The overall portfolio quality is typically AA. The benchmark for this strategy is typically the ICE Bank of America 1-5 Year U.S. Treasury Index. Separately managed portfolios are managed according to client preferences and restrictions - including customizable liquidity and holdings. Diversification and capital preservation are key components of portfolio construction.




## **S&P Credit Quality Distribution**
